Part III, Line 4a Program Service Accomplishments	In 2015, Imagine Science Films Corp held its 8th Annual New York Film Festival, satellite events The 8th annual Imagine Science Film Festival in New York was the biggest yet It took place from October 16-24, 2015 on the theme of "AIR" The festival included 136 films (8 features, 128 shorts) from 31 countries around the world, including 75 premiers and featuring 59 female directors and 86 male directors Similar to past festivals, we traveled to venues throughout the Tri-State area including Manhattan, Brooklyn, Queens and New Jersey with partners such as Google, The American Museum of Natural History, The New School, The Museum of the Moving Image and The Rubin Museum Peter Metler, John Mhiripiri, Nicola Twilley, John Steele and Summer Ash donated their time as jury members voting on The Nature Scientific Merit Award, The AAAS Scientist Award and Nanotronics Visual Science Award For the second year, the New York Festival hosted a 48-hour Film Competition pairing scientists and filmmakers in competition to make the best science short In addition to the New York Festival, Imagine Science launched the first annual Imagine Science Abu Dhabi festival in partnership with New York University Abu Dhabi (February 2015), and was a guest programmer at the Rencotres Internationales Science & Cinema festival in Marseille, France (November 2015) Imagine Science also created original film content for web distribution and educational purposes, its Field Work banner These short films are freely available and serve to explore and demonstrate the ways science and art can come together Our main sponsors are AAAS/Science, MacMillan Publishing Group (Nature Magazine), NYU-Abu Dhabi, NYU and Columbia University
