Healthcare Access & Advocacy. Under this program, United Women of East Africa Support Team (UWEAST) increases understanding of language access conditions and barriers in health care settings among residents, community leaders, and institutional leaders through a community-led research and policy campaigning. In addition, UWEAST increases understanding among youth, residents, and community leaders that would improve access to organized sports for Muslim girls in City Heights as evidenced by Women and Girls Only Swimming Class held at Copley-Price Family YMCA. Finally, we improve access to culturally appropriate and healthy school meals for City Heights children and youth through a community led research, policy development awareness campaign as evidenced by our "Halal Lunch" for students in the Crawford-Hoover Clusters.

Women's Health & Concerns. UWEAST conduct women's monthly health educational workshops commonly referred to as to reach the women of East African community. These workshops, commonly referred to as "Dialogue with the Doctors", on topics such as Parent Education Support and Empowerment, Community and health (arthritis), Stress Management, Hepatitis, Diabetes, Pre and Postnatal Health, Breast Cancer- Nutrition, Healthy Lifestyles and Fasting Healthy. In addition, we address their concerns for affordable housings, securing adequate food, and signing up for affordable healthcare. Finally, UWEAST addresses East African women concerns about the growing intergenerational gap with their "Americanized Daughters" by having expert quest to lead group discussions between mother and daughter to foster a more positive relationship between them.

Mental Health (Hwyatt): This 3 years program is designed to advance mental health for 1st and 2nd generation East African refugees men and boys of in urban area of San Diego. Our goals are threefold. One, to produce an actionable prevention plan that reflects principles, values, and community-level focus of the Making Connection Initiative. Two, develop a proposed partnership structure that supports community-level decision making and project accountability. Finally, as a part of our evaluation activities, we will include the development of a Theory of Change and logic model which will be determine by the type of project strategy being developed.
