ANNUALLY EITHER ON ITS OWN INITIATIVE OR UPON RECOMMENDATION BY A BOARD COMMITTEE, THE BOARD BY RESOLUTION MAY ESTABLISH A STATEMENT OF PURPOSE, DUTIES AND RESPONSIBILITIES FOR ANY BOARD COMMITTEE NOT INCONSISTENT WITH THESE BYLAWS EXECUTIVE COMMITTEE THE EXECUTIVE COMMITTEE SHALL CONSIST OF THE CHAIR AND VICE-CHAIR OF THE BOARD, ALONG WITH AT LEAST ONE (1) OTHER DIRECTOR THE EXECUTIVE COMMITTEE HAS THE AUTHORITY TO ACT ON BEHALF OF THE BOARD IN CONDUCTING THE AFFAIRS OF THE CORPORATION BETWEEN MEETINGS OF THE BOARD OF DIRECTORS THE EXECUTIVE COMMITTEE PROVIDES DIRECTION, COUNSEL AND OVERSIGHT TO THE CEO IN THE CONDUCT OF THE CORPORATION'S DAY TO DAY ACTIVITIES THE EXECUTIVE COMMITTEE SHALL ALSO DEVELOP THE CORPORATION'S ANNUAL BUDGET (INCLUDING PLANS FOR THE FUNDING THEREOF), WHICH SHALL BE PRESENTED TO THE FULL BOARD FOR APPROVAL, AND SHALL MONITOR THE CORPORATION'S FINANCIAL PERFORMANCE RELATIVE TO ANY SUCH BUDGETS SO APPROVED AUDIT COMMITTEE THE AUDIT COMMITTEE SHALL CONSIST OF NO FEWER THAN THREE (3) AND NO MORE THAN FIVE (5) MEMBERS OF THE BOARD, EACH OF WHOM THE BOARD HAS SELECTED AND DETERMINED TO BE INDEPENDENT IN ACCORDANCE WITH GUIDELINES ESTABLISHED BY THE BOARD THE CHAIR OF THE COMMITTEE IS DESIGNATED BY THE BOARD AND WILL PRESIDE AT MEETINGS OF THE COMMITTEE COMMITTEE MEMBERS SHOULD HAVE A BASIC UNDERSTANDING OF FINANCE, ACCOUNTING AND FUNDAMENTAL FINANCIAL STATEMENTS AT LEAST ONE (1) MEMBER OF THE COMMITTEE WILL HAVE A SOPHISTICATED UNDERSTANDING OF FINANCIAL REPORTING AND ACCOUNTING AS DETERMINED BY THE BOARD THE AUDIT COMMITTEE PROVIDES COMPOSED OF AT LEAST THREE (3) MEMBERS WHO ARE INDEPENDENT OF AND NOT COMPENSATED BY UI LABS IF THE CHAIR OF UI LABS' BOARD IS NOT A MEMBER, THE CHAIR MAY ATTEND MEETINGS OF THE COMMITTEE AND VOTE ON COMMITTEE ACTIONS NO MEMBER OF THE COMPENSATION COMMITTEE WILL BE A STAFF MEMBER, A RELATIVE OF A STAFF MEMBER, OR HAVE ANY RELATIONSHIP WITH STAFF THAT COULD PRESENT A CONFLICT OF INTEREST ON AN ANNUAL BASIS, THE COMPENSATION COMMITTEE IS CHARGED WITH THE RESPONSIBILITY TO RECOMMEND TO THE BOARD AN APPROPRIATE COMPENSATION FOR UI LABS CEO AND TO REVIEW AND APPROVE THE COMPENSATION OF UI LABS OTHER KEY EMPLOYEES WHO HAVE SUBSTANTIAL INFLUENCE OF THE AFFAIRS OF THE ORGANIZATION AND TO REVIEW AND APPROVE MANAGEMENT INCENTIVE COMPENSATION POLICIES AND PROGRAMS GOVERNANCE AND NOMINATING COMMITTEE MEMBERS OF THE GOVERNANCE AND NOMINATING COMMITTEE ARE SELECTED BY THE EXECUTIVE COMMITTEE THE GOVERNANCE AND NOMINATING COMMITTEE REGULARLY REVIEWS HOW THE BOARD IS FUNCTIONING AND WHETHER
