The governing body of Holy Spirit Memorial Foundation consists of 10 members. The 10 members include the Rector of Holy Spirit Parish, three members appointed by the Rector, three members appointed by the Vestry of Holy Spirit Parish, and three members appointed (elected) by the parish at the Annual Meeting of Holy Spirit Parish which is held every January. The Board members are all volunteers and receive no compensation. The Treasurer is a volunteer who has no voting rights and has no authority over the members or decisions made by the members. Meetings are held quarterly. A budget determining the cash amount of support to the affiliated church, Holy Spirit Parish, is based on the earnings of the investments and is approved by the governing body of Holy Spirit Memorial Foundation. The checks written to Holy Spirit Parish are signed by two authorized persons, two members of the Foundation or one member of the Foundation and the office Administrator. All minutes of the Foundation meetings are available at the Holy Spirit Parish Office.

The monthly financial statements are distributed and reviewed by voting members and approved quarterly. The annual financial statements are inspected by an independent auditor and a certificate issued. The statements are presented at the Annual Meeting of members of Holy Spirit Episcopal Parish. The Form 990 is available at the Holy Spirit Parish office for review.

The by-laws and financial statements are available to the public at the Holy Spirit Episcopal Church office. The financial statements are presented quarterly at the Memorial Board meetings and reviewed by an independent auditor annually.
