Montana Conservation Voters Education Fund's primary exempt purpose is to provide research and public education to the members of conservation and environmental organizations in Montana, and other interested Montanans to protect Montana's clean air and water, wildlife, forests and open space. MCVEF seeks a more informed, educated and empowered conservation and environmental community in Montana, who takes part in this state's democratic process.

Conservation Policy Program: At the state level, MCVEF had a robust public policy and public education program related to the 2015 Montana State Legislature and the 2015-2016 Legislative Interim.

Another state priority was to assess the impact of a proposal to transfer federal lands to the state. As in 2014, MCVEF provided policy analysis, distributed public information, coordinated 2 media stories, prepared briefing materials and facilitated comments to the EQC. MCVEF was responsible for generating over three dozen comments to the EQC, as well as letters to the editor.

A grant of \$40,000 was provided to Montana Conservation Voters for public policy services, including analysis of state legislative proposals; preparation and distribution of briefing papers; coordination of meetings with allied conservation and environmental groups; and coordination of 5 community meetings with state legislators after the 2015 session (Billings, Bozeman, Missoula, Great Falls and Whitefish, MT).

At the federal level, MCVEF coordinated the Climate Action Coalition and Clean Air

Campaign, working in partnership with the national League of Conservation Voters Education Fund and over a dozen conservation, public health and fish and wildlife groups. The key focus was to assess the proposed EPA rule to reduce carbon emissions in the United States by 30% by 2030. MCVEF worked to educate citizens, local and statewide decision makers on the impacts of climate change and the EPA rule on public health, fish and wildlife and a clean energy future, and to ensure the authority of the Environmental Protection Agency to protect public health under the Clean Air Act, including from the negative impact of carbon emissions. MCVEF leaders were part of letters to the editor and guest commentaries, and attended over a dozen meetings and events on the Clean Air Act, climate change and the Production Tax Credit.

Additionally, MCVEF sponsored or co-sponsored twenty one meetings and events throughout 2015 on clean energy and climate change, and reached out to legislative, statewide and local officials to engage them in this dialogue as well. When the Clean Power Plan rule was issued in final form in October, 2015, MCVEF assisted in coordinating comments and an assessment of the impact of the final plan on public health, fish and wildlife, water quality and jobs.

Montana Conservation Voters Education Fund continued its work on safe chemicals in the first half of 2015 by monitoring federal policy associated with toxic chemicals in household products. MCVEF leaders worked to educate the public and local decision makers about the re-authorization of the federal Toxics Substances and Control Act (TSCA) and proposals to ensure greater safety in household products and chemicals. MCVEF partnered with the national League of Conservation Voters Education Fund and the Safe Chemicals Coalition on this campaign.

Community Organizing, Outreach and List Enhancement: From August - December, 2015, MCVEF worked with two other organizations on a grassroots campaign to oppose state and federal measures that would transfer federal lands to states. The measures were defeated by the 2015 legislature but some legislators persisted in advocating the proposals in the summer and fall of 2015. MCVEF's campaign included:

visiting with 1,093 citizens at their doors, followed by calls to another 4,296 over the phone to discuss the proposals and identify their position. MCVEF followed this up with postcards mailed to ~ 5,000 citizens to submit a postcard addressed to Governor Steve Bullock to establish a pro-active state public lands program. Over 10% of those receiving the mailing responded. MCVEF also included a series of email communications, as well as targeted social media. This campaign is shaping up to be a key MCVEF program area, as an overwhelming majority of Montanans support protection and broad access to state and federal lands, and oppose transfer and privatization proposals.

MCVEF's 2015 List Project engaged 9 organizations who together provided over a dozen lists to combine and enhance with demographic and economic information. The lists were returned to participating groups and merged for collective use upon permission of participating groups.

MCVEF coordinated the Billings Conservation Roundtable in 2015, with 7 educational sessions ranging from the Clean Power Plan to public lands protection to area bike trails. The MCVEF Missoula Conservation Roundtable was folded into regular Missoula MCV chapter meetings, and has prioritized work on the Missoula County Growth Policy.

MCVEF also took part in 6 of the 8 Flathead Conservation Roundtable meetings convened in 2015 and led sessions at 3 of these gatherings.

Leadership and Staff Development: : Four MCVEF staff and two board members attended the national League of Conservation Voters/LCV Education Fund training meeting in Annapolis, MD; three staff and one board member attended a fundraising training in Seattle, WA; one staff attended a public policy and advocacy training sessions in Washington, DC; one staff person attended a leadership training hosted by the Ballot Initiative Service Center; one staff person attended a leadership training sponsored by NTEN; and one staff person took online training to learn how to effectively utilize MCVEF's new data base.

Additionally, MCVEF launched a strategic planning process that included a January, 2015 retreat, followed by periodic leadership calls to finalize the plan. This was done working with a consultant who conveyed key planning principles, and who assisted in the creation of the plan. This strategic planning process was the first such experience for four Board members and four staff.

A new MCVEF Executive Director was recruited, screened, hired and orientation and training began in late 2015. This included an overview to organizational goals and objectives, fundraising training, personnel and financial management. This work included an extensive search process with a team of MCVEF Board members, who were assisted by a consultant and who learned basics of job description development, skills assessment and recruitment and screening interview techniques.

MCVEF Non-partisan Civic Engagement and Ballot Measure: : MCVEF coordinated the Voter Rights Coalition, a diverse group of non-partisan organizations, to assess various bills before the 2015 legislature affecting voter registration, vote by mail and polling place access. Groups supported online voter registration, working with the Montana Secretary of State and Montana clerks and recorders (county election officials). While the proposal didn't pass, a larger base of support has been built, and groups subsequently met in fall, 2015 to discuss next steps for a similar proposal in 2017. MCVEF met with the Secretary of State and election officials in Yellowstone, Gallatin, Park, Lewis and Clark and Flathead counties to request clear and accessible information on web sites and through social media about how inactive voters could "re-activate" and vote in 2015 city elections. All county election officials made subsequent improvements on their web sites and some did publicity. This exclusion is a policy dilemma that MCVEF has been addressing for several years, and which has come before the legislature. MCVEF also reached out via email and Facebook to the handful of its supporters who were on the inactive list and helped them update their voter registration.
