In our Conservation Program, central to our work is the protecting of core ecosystems like national parks, along with the corridors that keep these areas connected, for wide-ranging species like wolverines and grizzly bears. Protecting habitat across multiple jurisdictions and restoring crucial wildlife corridors fragmented by roads, development and settlement allows wildlife to move freely and find suitable mates and habitat.
In 2015 we continued these efforts in the Cabinet Purcell Mountain Corridor, a high-priority linkage zone stretching from Missoula, Montana north to the Canadian border. This is an area critical for grizzly bear recovery. Through working collaboratively with our diverse partners in the area, including agencies, scientists and non-profits, we addressed land use, transportation and wildlife conflict issues through education, community engagement, and research. As a result of focused efforts there has been a significant increase in grizzly bear numbers over the past ten years. 2015 also saw Y2Y and our partners initiate an education campaign to convince others of the need to make U.S. Route 20 safer. This is the first major road that animals encounter as they roam west from Yellowstone National Park. In addition to public education we also identified key corridors in this area where innovative fencing and overpasses could reduce collisions, saving lives of wildlife and humans.

4b (Code:) (Expenses \$ 224,929 including grants of \$ 5,000) (Revenue \$)
In our Communications Program, Y2Y worked to educate the public about the importance of healthy coexistence of wildlife and human communities within the Y2Y region. In 2015 we developed and delivered public presentations and publications that shared how citizens can help be part of the solution. Through newsletters, our website, and other print print and electronic publications Y2Y provided educational materials that inspired communities to care for the natural world and taught thousands how to live with nature.

Policy Program
To achieve long-term success, Y2Y works at both at a place-based level but also at a higher level to ensure an enabling socio-political environment. As such, we work strategically with partners on a set of policy-level issues at local, regional and global policy levels such that these policies then support on-the-ground conservation advances. In 2015 we continued our efforts to maintain, build and support a growing movement of government entities to conduct their natural resource management work in the context of larger landscape conservation. In 2015 we initiated a cooperative effort that will set strategies for public land use management on 6.2 million acres in central Idaho.
