Statement 1 - Explanation for Not Filing on Time**Description**

The Foundation's president, Larry Crain, met with an attorney in late 2015 in order to have the Foundation's organizational documents filed. In connection with that meeting, Mr. Crain donated a promissory he held to the Foundation in December 2015. During 2106, Mr. Crain could not get verification from said attorney that the organizational documents were ever filed. In early 2017, Mr. Crain retained a different law firm to address these issue. The new attorneys determined that the documents had been filed with the State of Arkansas but Form 1023 had never been filed. As a result, Form 1023 and Forms 990-PF for 2015 and 2016 are being filed concurrently. Form 1023 is being filed within 27 months of organization and the 2016 Form 990-PF is being filed timely under an accepted extension as filed on Form 8868. All future returns will be filed timely. We request abatement of any penalty for late filing as these circumstances were beyond our control and we have taken decisive steps to remedy this issue.
