SCHOOL AT DANCERS' WORKSHOP PROVIDES CREATIVE MOVEMENT AND DANCE INSTRUCTIONS FOR YOUTH AGES 18 MONTHS - 18 YEARS WITH A PROGRESSIVE CURRICULUM IN BALLET AND MODERN TECHNIQUE AS WELL AS CLASSES IN HIP-HOP AND OTHER POPULAR DANCE STYLES. THE SCHOOL ALSO PROVIDES FITNESS AND DANCE INSTRUCTION FOR ADULTS OF ALL AGES AND ABILITIES IN STYLES INCLUDING MODERN, BALLET, ZUMBA, JAZZ, BOOTY-BARRE, BALLROOM, AFRICAN, FLAMENCO, SALSA AND TANGO. THE VISION OF DW'S OUTREACH PROGRAM IS TO CREATE DIVERGENT THINKERS BY ASKING QUESTIONS AND EXPLORING CLASSROOM CONCEPTS USING MOVEMENT AS THE VEHICLE.
