Network Programs As part of its coordinated foreclosure response, the Center for New York City Neighborhoods contracts with several legal service organizations and housing counseling providers. The Center's legal service partners provide homeowners in foreclosure with advice and counsel, direct representation in court, and pro-se assistance. The Center's housing counseling partners provide homeowners with one-on-one counseling services to save their homes or negotiate a sustainable housing solution. Dedicated counselors and support staff work closely with the homeowner to develop a budget, assess mortgage documentation, negotiate with lenders and servicers and assist the homeowners with other non-mortgage needs. The Center also provides technical assistance to its network of providers with training and expertise on housing counseling, legal services, and consumer education and protection in New York City. As part of its consumer education, the Center has undertaken a loan-scam prevention education and outreach campaign with the assistance of the New York State Office of the Attorney General (OAG).

Build it Back The Center for New York City Neighborhoods provides case management services specifically dedicated to Hurricane Sandy impacted homeowners. A major component of these services are provided as part of the New York City Build it Back (BIB) program run by the Mayor's Office of Housing Recovery (HRO) and uses federal community development block disaster recovery funds to assist homeowners recovering from Superstorm Sandy.

Mortgage Assistance The Center administers the New York State and New York City Mortgage Assistance Programs on behalf of the New York State Office of the Attorney General (OAG) and the New York City Department of Housing Preservation and Development (HPD). The NYS Mortgage Assistance Program represents a \$18,000,000 fund to provide zero-interest loans to distressed New York Homeowners at risk of foreclosure.
