In 2014, Sunrise Ministries Inc. loaned that amount to make repairs required by the Provincial government to house additional orphans, and has now forgiven this debt.

3. 990-EZ form Part IV: Sunrise Ministries Inc. paid two independent contractors" to assist with administrative office tasks on a part-time hourly basis with no benefits. Paula Saxon was paid \$ 1,400.00 was paid to her with no taxes withheld; Kay Lynn Baker was paid \$ 430.00, with no taxes withheld, and both were mailed 1099s to use for 2015 taxes. Mr. Robert Atherton received \$ 548.80 in payment for expenses paid personally for ministry costs incurred under an "Accountable Plan". Mrs Jo Ann Atherton is exempt from Social Security withholding and withholding taxes per her exemption letter received when the 501(c)(3) application was approved.
