 This Foundation was organized in 1990 by the Lions members from both CO and WY to serve as the legal entity through which the Lions of both states could publicly raise the funds that the Lions needed to satisfy the commitment that both states had made to cover their commitment to provide 1/2 the cost to construct the new facility that houses the Eye Institute located on the Aurora campus of the Univ of Colo Health Science Center, which facility was built and opened in 2001. We continue to assist the Eye Institute by funding some of the new equipment needed.

 During 2015, our Foundation was primarily engaged in raising funds to complete our new commitment made in 2014 to provide a total of \$1,314,650 to help the Univ of Colo to expand the physical building completed in 2001. Our new commitment was made to cover the cost of 10 new examination lanes in the newly expanded RMLEI facility. Our fundraising plan was and is to apply for assistance from Lions Clubs Int'l Foundation in Oakbrook IL (LCIF) to provide matching funds to ours to help in satisfying our commitment that was due to be paid over a three year period. \$225,000 was received from LCIF during 2015 which was matched by us and applied towards the \$1,314,650 commitment.

We also continued to provide funds to assist indigent patients in participating in the low vision examination and treatment program. \$750 was expended by our Foundation in 2015 on this program.
