Additionally, the following substantive changes were made: -Reduce the maximum and minimum number of board members to 20 and 10, from 25 and 13, respectively. -Establish a Joint Nominating Committee for the purpose of recommending CCALT board member nominees. The Joint Nominating Committee is comprised of three members appointed by the CCALT board president and three members appointed by the Colorado Cattlemen's Association board president. -Require a minimum of three regular meetings per year. -Specify that any director may be removed by a two-thirds vote of the full Board of Directors. -Establish the position of First Vice President of the Board of Directors and assign duties to the position. -Establish policies for election and removal of and specify terms and term limits for officers of the Board of Directors. -Establish and provide authority to an executive committee of the Board of Directors. -Update and clarify policies regarding the establishment, composition and terms of service on committees of the Board of Directors.
