Tribe membership now totals 2210 people. The ministry has a Facebook group page that has over 58,400 Likes," another Facebook page for women with 51,200 Likes," a " & Sons" Facebook page with 5,400 Likes. Ransomed Heart Ministries maintains a ministry to young men with an "& Sons" e-magazine that goes out regularly to a list of 8,500, and with 5800 Instagram subscribers.
