Operate a medical clinic in the village with intermittent medical care provided to the villagers as needed. Continued job creation program for 12 village women, two managers and one driver/security guard. Built new job creation headquarters. Operated a vision clinic and handed out prescription glasses to needy individuals. Added a seamstress to the job creation program.

Provided sponsorships and support services to over 75 orphaned children living in three orphanages in the Chiang Mai and Mae Sot regions of Thailand.
