	The New Mexico Acequia Association had a successful year in working toward our mission of protecting water and acequias, growing healthy food for our families and communities, honoring our cultural heritage. NMAA built upon our long-time education and outreach work through our Acequia Governance Project, which is designed to build capacity of acequias to successfully govern their acequias and protect their water rights, the Sembrando Semillas Project, which is an intergenerational youth and family program, and Escuela de las Acequias, which is focused on leadership development. We also engaged in membership development, policy development, and communications and outreach. For the first time, NMAA developed a statewide list of acequias with contact information which was used to conduct a statewide survey and needs assessment. The report on the needs assessment will be used to inform ongoing program development by NMAA leadership and management. Acequia Outreach and Organizing: NMAA engages leaders in outreach and organizing to support leadership development, community-based organizing, and capacity building. We coordinated numerous educational activities and engaged acequias throughout New Mexico through outreach and communications through the following activities: Gave presentations and provided training at 14 acequia meetings with 480 participants. NMAA staff are often invited to attend local acequia meetings to give presentations are training on water rights, acequia governance, and infrastructure funding. Two statewide meetings, the Mayordomo Commissioner conference and the Congreso de las Acequias, with a combined 375 participants. The statewide events include presentations and dialogue on current issues such as water rights protection, acequia governance, agricultural revitalization, and youth and family engagement. Published 4 quarterly, hard copy newsletters which is distributed to 6,037 recipients throughout the state. The newsletter serves as the largest communications network for acequias in the State of New Mexico. Also published bi-monthly online newsletters disseminated to 2,001 individuals. Social media posts often reach over 1,500 individuals. Provided organizing support to three regional acequia associations including Los Nueve Acequias del Rio Grande, South Valley Regional Association of Acequias, and the Cow Creek Regional Acequia Association. Hosted 2 workshops with 145 participants on protecting agricultural land and tips on keeping the agricultural land tax status on acequia farmland and conducted outreach statewide resulting in 80 new applications to the Resource Conservation Partnership Program (RCP), a conservation program of the Natural Resource Conservation Service (NRCS) of the USDA. Created an inventory of 533 acequias throughout the state including the name of the acequia, county, water source, and contact information. Based on this list, NMAA conducted a statewide needs assessment by conducting a survey in which we received 374 responses. The data was summarized in the 2015 Acequia Needs Assessment Report which has been shared with acequia leaders, state and federal agencies, and policymakers. The report includes a summary of findings related to technical assistance needs of acequias in relation to acequia governance. Acequia Governance Project: The purpose of this project is to protect the water rights and agricultural lands of acequia communities by strengthening the capacity of acequias and community ditches to protect historic acequia water rights and to manage water for the benefit of their respective communities. This project utilizes a culturally appropriate approach to community education. This includes one-on-one technical assistance and community based workshops in addition to creating educational materials that are updated annually based on lessons learned in the field. Hosted seven workshops on acequia governance, legal compliance, and financial compliance with 234 participants. Workshops cover the requirements of compliance with state law with regard to bylaws, membership and voting, audits, budgets, and open government requirements. Additionally, workshops cover information about available funding sources for acequias and a how-to overview on how to plan a project and apply for funding. Provided technical and legal assistance to acequias in updating their bylaws. Acequias are required by New Mexico law to have bylaws and NMAA, along with NM Legal Aid, provided specialized assistance that led to the completion of new or updated bylaws for 32 acequias. Provided technical assistance to 32 acequias in the completion of Infrastructure Capital Improvement Plans (ICIPs) which are plans used by the State of New Mexico to identify infrastructure needs across the state. Assistance includes consultation on project management, sources of funding, and the state appropriations process. Partnered with the New Mexico Association of Conservation Districts and the New Mexico Interstate Stream Commission to leverage state and federal dollars for acequia projects and to collaborate on planning to improve outcomes in completion of acequia projects. Provided 443 technical assistance services, along with our partner NM Legal Aid, to acequias on a variety of issues related to acequia governance including water rights, water management, roles of officers, collection of assessments, enforcement, easements, financial compliance, infrastructure issues among many others. Sembrando Semillas Project: Sembrando Semillas is an inter-generational network which serves to cultivate a cadre of acequia leaders, with a special emphasis on youth, passionate about their identity as land-based people who express their <i>querencia</i> through working the land, sharing water, and growing food. Participants work on agricultural-related projects in their own communities with a strong focus on acequia traditions and values. Within the network, participants learn from each other by exchanging ideas, visiting each others projects and communities, and doing hands-on activities together. Projects are primarily community based but also involve local schools where possible. Participants in the project have opportunities to receive training on multimedia production, artistic expression, community organizing, and policy advocacy so that they can be leaders in the acequia movement in New Mexico. Supported six local groups comprised of youth and families in the communities of Mora, Chamisal, Abiquiu, Servilleta, and two groups in Atrisco who altogether hosted 46 activities about acequia agriculture, food traditions, media and messaging, and acequia policy issues for 945 participants, including 543 youth (note that there are some duplicates in this number). Local partners included Almacen y Troja, Chocoyole Farm, El Rincon Farm, Pueblo of Abiquiu Library, Los Jardines Institute, Cornelio Candelana Organics, and Grow the Future. Piloted projects connecting local schools to our local community-based partners and farms to provide acequia-grown food and farm-field trips to teach children about locally grown food and the important role of local farmers. Partners also collaborated local schools including La Jicanta Charter School, La Tierra Charter School, Amy Biehl High School, Health Leadership High School, Van Buren Middle School, Wilson Middle School, South Valley Academy. Local schools work with a local acequia farmer for site visits, healthy snacks, and connecting acequia agriculture to nutrition and good food. Hosted, along with our partners in the New Mexico Food and Seed Sovereignty Alliance (Honor Our Pueblo Existence, Tewa Women United, and Traditional Native American Farmers Association) our sixth annual seed exchange with 150 participants including numerous seed savers from acequia and Native American communities. The event is instrumental in building an advocacy support base for traditional foods, traditional agricultural methods, and protection for heirloom (non-GMO) seed varieties specific to the region. The event also promotes community health, based on food security provided by increased access to healthy, fresh, locally grown food. Policy Advocacy and Leadership Development: NMAA engages members and supporters in identifying issues of importance to acequias statewide through our various workshops and meetings, working with acequia leadership and policymakers in issue analysis, and developing policy recommendations that are supported by our statewide membership through an annual cycle of writing and adopting resolutions. In 2015, NMAA held a legislative training for our membership in partnership with the American Friends Service Committee (AFSC), held three meetings of our Policy/Legislative Committee to conduct issue analysis, and developed policy recommendations in the form of four resolutions addressing forest management by the United States Forest Service, water rights issues relating to the New Mexico Office of the State Engineer.
