The service area is southern Arizona. Completed 280 home visits to over 1,000 individuals, and conducted over 50 outreach events to over 10000 community members. Installed over 4000 smoke alarms including alarms for the deaf or hard of hearing, 500 carbon monoxide alarms in homes. Conducted outreach on rainwater harvesting, planted over 100 trees and installed 32 rainwater harvesting systems. Conducted research on a low-income loan programs for rainwater harvesting. Conducted healthy homes interventions for excess heat, mold and moisture, falls and electrical and other health, environmental and safety hazards. Conducted community risk reduction training throughout southern Arizona.
