In 2015, Release the Fear worked with 1415 students in 74 Bridging Possibilities Workshops and 75 students in 3 Discover U Summer Camp programs, a 47% increase over the past 2 years Since 2002, Release the Fear has interacted with over 8,000 Arizona youth, empowering them with life skills to help them cope with many of the issues they face on a daily basis Youth completing Release the Fear workshops begin to realize their positive potential and realize that the matter A 3 year longitudinal study completed by the Arizona Department of Juvenile Corrections in October 2015 showed the positive effect the Release the Fear programs have on recidivism Of the 728 youth studied, 468 youths have been released from ADJC care and 318 of those released have not returned to ADJC Release the Fear is making a difference in their future and in the future of Arizona In October 2015, Robert Miley was selected as one of 56 national artists to contribute to "America Celebrates Ornaments across the USA" - the 2015 holiday display in the Presidents Park at the White House in Washington DC Mr Miley had the youth from the Release the Fear workshops help create the christmas tree ornaments that were then displayed in our nation's capital This was a once in a life-time experience for these youth that had an enormous impact on their lives Looking forward to 2016, Release the Fear is projecting a 50% increase in the number of youth they expect to reach
