The Organization did not host the conference in 2015. The Organization also presented live teleforums throughout the year. The format is a call-in forum, similar to small group meetings and are held throughout the country. The forums feature significant leaders in their respective fields and are designed to educate and inspire. The Organization holds weekly peer-to-peer forums and small group meeting with between 8-12 individuals each taking place across the country within its chapters. The Organization produces a monthly newsletter e-mailed to partners and friends to keep them informed of the activities and happenings within the Organization.
