3rd Crop Initiative - The core of our work, is an effort to promote alternative crops that supply ecological uplift and diversify the landscape while providing economic return to the farm family and supports society in general. This crops may provide food, fiber or fuel. Developing educational programming and delivering that programming through workshops, on farm demonstrations, field days, research, educational materials and one on one technical assistance to farmers are the major outreach methods we utilize. Our programming includes cover crops and drainage water management which includes saturated buffers, water storage and development of the tile outlet treatment train concept for addressing agricultural nonpoint source pollution. We are beginning to evolve our programs with soil health management on farmland utilizing 3rd crop concepts.

Local Foods - Rural Advantage provides technical assistance and support to expand local food programming in south central Minnesota. We lead a Learning Group during the winter months to bring in speakers on growing, marketing, storage and harvest of local foods. We coordinate the Fairmont Community Gardens with 155 twenty feet by 20 feet garden plots serving about 85 families. We assist several Farmer's Markets in the region and manage a merchant terminal at the market in Fairmont that takes EBT, credit and debit transactions. The customer get tokens in exchange and use them to purchase food at the many vendors at the market. We develop and deliver several workshops and meetings to promote and market local foods. The revenue is from the exchange of tokens between customers and vendors at the farmer's market. customers can use their EBT, credit or debit card to get tokens if they do not have cash to purchase produce.

Rural Advantage Research and Demonstration Farm - We have developed a strategic plan for our research and demonstration farm near Le Roy, MN. We will be ramping up our demonstration of alternative crops, on-farm research and field days at the farm. The farm allows us to expand our outreach for all of our programming. The income we receive is from land rent and house rent on the farm. These funds goes to pay expenses at the farm including insurance, real estate taxes, repairs, maintenance and farm out reach programming.
