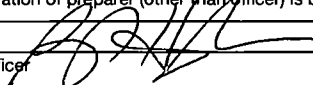

School Attendance - School attendance is challenging for a majority of Togo's poor families who cannot afford uniforms and school supplies for their students. GACE collects donations of the most basic school supplies which are assembled into kits by staff in Togo and distributed to schools in very poor communities so that every student has pencils, pens, markers and other supplies that can last for most or all the school year. 12,000 students were served in 2015, with program expenses of \$65,520.00. In 2015 GACE received funds from Alaffia to build 5 schools for elementary and kindergarden. Two were completed in 2015 and 3 in 2016. Program costs for school constructions in 2015 were \$36,859 USD. The Bicycles for Education program also helps increase the student retention rate in Togo by distributing donated bicycles to 6th-12th grade students. Program costs were \$32,064 in 2015 and 800 bicycles were distributed at no charge to students who maintain grades and attendance to retain the bicycle. As part of the school constructions, Alaffia funded GACE to build 605 benches and desks for furnishing the schools at program cost of \$13,310 USD.

Eyeglasses Donations - Obtaining corrective eyewear costs about four times the average annual wage in Togo, making access to vision care beyond the reach of a great majority of the population with vision impairments. Vision impairments among working adults can deeply impact their family's welfare and therefore has a ripple effect on other family members and their communities. Quality of life, including mobility and daily self-care for the elderly is also deeply impacted for many without access to corrective vision. Vision impairments are another barrier to education for poor young students. In 2015, GACE collected 8,500 pairs of donated eyeglasses for distribution in Togo through mobile services at health clinics in rural communities.

In 2015, 902 mothers and their infants were provide with complete prenatal, birth delivery, and post-natal care through the Safe Birth project of GACE's Maternal Health program. This program aims to reduce Togo's very high MMR and IMR rates as well as providing training on family planning & eradicating excision (female genital mutilation, FGM). Women who become sick or die in childbirth, or who must care for sick babies, leave a gap for surviving or other children, reducing their chances of attending school or gaining more valuable livelihoods in future.
