the audit was reviewed by the Board.

Part VI 15a, b - Visual Art Institute is a member in good standing with the Utah Nonprofits Association. They track the salaries and

responsibilities of nonprofit organizations and makes comparative information available. This has been used to review the

decision of compensation of Key Employees. Additional information has been sought from outside organizations.

Part VI 19 - Visual Art Institute makes its tax records available upon request. A copy is kept accessible in the office.

Part VII 1a, 15c, d - Shelley Young has worked part-time for Visual Art Institute as an instructor and office employee. Because of her

expertise and community connections, she was asked to serve on the Board. She is not compensated as a Board Member, only for her

hours teaching and working in the office.
