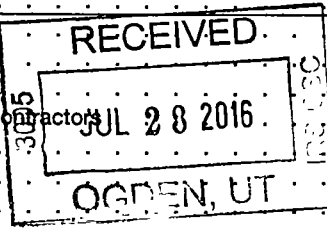

The Fund for Wild Nature's primary exempt purpose is to raise funds and provide small grants to promote the conservation

and protection of the Earth's wildlands, roadless and wilderness areas, wildlife and natural ecosystems.

Form 990-EZ, Part IV (c), EXECUTIVE DIRECTOR Salary - The value reported here (\$16,500) resulted from treating December 2014 salary paid

in January 2015 as a 2014 Liability. We did not pay Executive Director salary in December 2015, so there is no corresponding Liability in this

2015 report. Thus, \$1500 that was reported on the 2015 W-2 as actually disbursed in 2015 (total \$18,000) is accounted here as covering

\$1500 of the 2014 liability leaving \$16,500 as the net salary expense for 2015.
