Over 525 volunteers contributed to the effort in either teaching or administrative/supervisory capacities using ILP's effective method and curriculum for teach children English

Approximately 55 people participated in summer youth language camps in the United States taking English classes, living with host families, and participating in cultural events while traveling throughout the U S during the summer.
