From January 2015 through April 2015, the President of the Foundation approved four disbursements totaling \$110,000.00 for the purchase of improvements, modifications and equipment to and for a boat. The Foundation's purchase of such boat was authorized by the President in May 2014 as an investment and/or for use in direct charitable activities. In August 2015, the President discovered that the Foundation's Executive Director did not title the boat in the Foundation's name and, instead, registered ownership of the boat in the name of Copper River Wild Salmon Company, a non-exempt company in which the Executive Director has an ownership interest. Thus, the Executive Director misappropriated the 2014 and 2015 disbursements for his own benefit and, as a result, the Foundation has had a loss of assets.

Since discovering the misappropriation of funds, the Foundation terminated the Executive Director, engaged legal counsel, and has been working diligently to recover the misappropriated funds and/or boat and related equipment. In September 2016, the Foundation filed a complaint in the Superior Court for the State of Alaska, Third Judicial District at Anchorage (Case No. 3AN-16-8810), against the former Executive Director and his company to attempt to recover the misappropriated funds and/or boat and related equipment. The case is still pending at the time of filing this return.

The Foundation will file a 2015 Form 4720, *Return of Certain Excise Taxes Under Chapters 41 and 42 of the Internal Revenue Code*, to report the acts of self-dealing and related tax imposed on the self-dealer.
