Formal approval of the annual compensation package is documented in the minutes of the Board of Trustees' meeting. In Q4 2012, NAH engaged an independent group, CBIZ Human Capital Services Group, to perform an organization-wide compensation analysis, including a review of current compensation practices and development of a Market Based Compensation Plan. The compensation plan for 2013 was developed and approved by the Compensation Committee based on this analysis and presented to the Finance Committee/Board of Trustees in accordance with company compensation policies. In Q4 2013, CBIZ provided a report of actual 2013 and projected 2014 salary adjustments for all organizations in the Western US including specific healthcare industry compensation information. Their report included a recommended salary structure update for the next fiscal year. The Compensation Committee reviewed and approved the organization's salary structure including that of the CEO and other senior leaders for the next fiscal year.
