Once these budgets are approved they are normally funded on a quarterly basis to the grantee. At the end of the year the grantee submits a report to the Foundation as to how the grant was utilized. In addition, the scientists frequently make reports to the Foundation at its board meetings, and/or the Foundation Trustees make on-site visits to the research institutions.
