<p><b>29</b></p> <p>In 2015, most of our efforts went into our program to increase collaboration between Vineyard nonprofits as we continued to help lead and develop the Healthy Aging Task Force (HATF) we created in 2013 The HATF has over 70 volunteer members representing more than 35 health, human service and municipal organizations that serve Island elders There are 7 different work groups developing collaborative programs to address the various needs of our growing elder population Our Executive Director served as the HATF's Executive Director for 9 months of 2015 and 3 of our Board members serve on the HATF's Coordinating Committee In 2015 we also acted as fiscal agent for the HATF on 3 large grants One grant was to conduct a needs assessment of the elder population, which was completed in December with the results presented at a public meeting for over 60 community leaders Our Executive Director lead the needs assessment project which was mailed to 4,762 Island elders, had a response rate of 49% and gave us great insight into their needs The second grant provided funds for a part time Executive Coordinator for the HATF so our Executive Director was able to cut back his time spent on the HATF but he was still a member of the Executive Committee and was actively involved in implementing the Myseniorcenter program at all four Councils on Aging and overseeing the HATF strategic planning process which will be completed in 2016 The third grant was for conducting a feasibility study for constructing a skilled nursing or assisted living facility using the "Greenhouse" model Our Executive Director also sat on the committee overseeing the study which will be completed in 2016 (Grants \$ 10,428) If this amount includes foreign grants, check here . . . <input type="checkbox"/></p>	<b>29a</b>	95,981
