The harsh reality is that 250 million children worldwide are not learning to read and write, despite enrollment in school. Library For All is a nonprofit organization that has built a digital library to deliver quality educational materials in developing countries. Our mission is to make knowledge accessible to all, equally. We believe in providing individuals with the opportunity to learn, dream,

Haiti; Throughout 2015, we created and tested a digital library for four countries in the developing world. Library For All's first program country is Haiti, wherein we have been building and testing a collection of local language books for children since 2013. In 2015, the digital library for Haiti was filled with around 1,000 quality titles from local Haitian publishers and international publishers, available in Haitian Creole, French, English and Spanish. To support the growth of our digital library and our content, we hired a local team of 3 team members, including the former Director of the Haitian National Library in Haiti. As a result, Library For All established its first local office in Petion-ville, Port-au-Prince, Haiti. In 2015, the digital library reached students from a total of 24 schools.

Rwanda; In partnership with Bloomberg Philanthropies and the First Lady of Rwanda's Imbuto Foundation, we built a digital library for Rwanda that was made accessible to Rwandans in June 2015 via mobile phones and tablets. Our digital library was filled with 500 quality titles, sourced from international publishers and local Rwandan publishers, with each title approved by a local Rwandan Content Advisory Board. Access to quality content in English and Kinyarwanda encouraged a culture of reading amongst the Rwandan population. This initiative aligned with the Rwandan Ministry of Education's campaign "Rwanda Reads," as well as the Rwandan Government's "Vision 2020" to bring ICT to every school across the country.

Cambodia; In partnership with the Asia Foundation's Books For Asia, we launched a pilot of our program in Cambodia in five primary schools, and two mobile libraries in late November 2015. To assess the need for our platform in Cambodia, we collaborated with Books For Asia on a Book Availability Study. The purpose of this study was to measure access to reading materials at four sample schools. Results from the study demonstrated that the majority of children have less than 3 books to read at home. Our Cambodian Library contains 50 books in English and 50 in Khmer, sourced from local publishers and NGOs. The pilot demonstrated the potential of digital reading programs to increase access to reading materials across the Asian region, with the right technical and implementation support.
