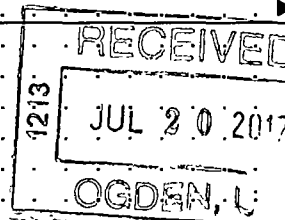

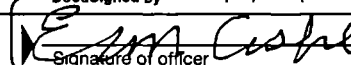

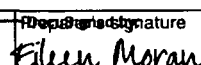

Like the whales we study, we are highly migratory. We spend half our time getting our feet wet in the field, wherever our work is needed, but the other half is spent using our science to inform smart decisions to conserve wildlife. We aim to enhance stewardship of the environment by providing the most accurate scientific information possible to those individuals and organizations responsible for environmental policy-making, by bringing the environmental consequences of human actions to the fore of public discourse, and by enhancing public understanding of the environment and the effects of human activities upon it.

Form 990-EZ, Part III, Line 28: The Oceans Initiative continues to carry out conservation-minded research and provides scientific information regarding the protection of marine species. Our 2014 programs assessing the impact of ocean noise on marine mammals continues. We also continue our work participating and engaging in meetings, workshops, and public lectures, and have served as a venue to disseminate our findings to stakeholders and wildlife managers. Conservation assessments, abundance estimation, bycatch mitigation, and marine protected areas research continue to be part of our ongoing projects and program areas. Ecosystem protections, endangered species preservation, and marine research are ongoing projects within our program platform.
