is a place where all are welcome to shop, seek pray and assistance, and be refreshed in a loving and caring environment. Arts and craft classes are offered for a nominal cost on a periodic basis. In addition, Son Glow Ministries, Inc, in coordination with Eve's Place (a 501 (c) (3) organization), assist individual job seekers with clothing for interviews and resume preparation. Many of the same individuals, customers at the boutique, also attend bible study classes held in the boutique after business hours.

The Boutique staff ministers to the downtrodden by paying for meals at local restaurants and pays for an occasional bus ticket to help a stranded soul get home. The number of individuals provided assistance and type of goods provided is recorded in Sales record daily on the day the assistance is provided.

Supported organizations selected for support are reputable organization that are vetted by local churches, school counselors, or or referral by organization with which Son Glow Ministries, Inc. has developed a close working relationship. In some cases members of the board of directors know the heads of the organization personally and monitor the activities by observation/site visits e.g., Vida Ministries, Christ Church of the Valley in Peoria, AZ.

Son glow Ministries, Inc provides assistance to indigent/homeless individuals in need of support for a variety of reasons and circumstances including the relief of hunger, funds for bus transportation; clothing; and religious items sold in the retail stores (Son Glow Boutique and Sparkle 'N Style) to the general public. These small random acts of kindness cost the ministry \$586.00 in FY 2015.

Comment 2: Part V, Line 3b--a "No" check mark. The Ministry did not have any unrelated business gross income of \$1000 or more during the FY 2015 and was not required to file a form 990-T.

Comment 3: Part V, Line 13--Son Glow Ministries, Inc is not a Section 501(c)(29) qualified nonprofit health insurance issuer, therefore, no additional information about reserves required or on hand is provided.

Comment 4: Part V, Line 13--Son Glow Ministries, Inc does not provide indoor tanning services, therefore, Form 720 was not filed because no payments were received.

Comment 5: Part VI, Line 2--The founders of Son Glow Ministries, Inc serve as Chair and the Statutory Officer/Secretary/Treasurer are husband and wife. Both are directors and officers of the corporation.

Comment 6: Part VI, Line 11b--Form 990 for Son Glow Ministries, Inc was reviewed by the members of the audit committee, committee of the whole, to determine accuracy of the information and conformance with applicable regulations. Each member of the committee (Board of Directors) is provided a completed copy of Form 990 with all attachments. The committee recommended that Form 990 for FY 2015 be submitted as written on February 18, 2016 during a regularly scheduled meeting of the Board of Directors.

Comment 7: Part VI, Line 12c- The Conflict of Interest Policy Manual designates the Secretary, Son Glow Ministries, Inc., as the compliance official. Each director/officer's conflict of interest statement is updated and reviewed annually in conjunction with the ministry's annual meeting generally held in the month of October.

Comment 8: Part VI, Line 15a and 15b--Son Glow Ministry is aware of the process used to determine appropriate levels of compensation for nonprofit organizations which primarily support religious organizations. Son Glow Boutique (\$47042.00) ; Sparkle 'N Style (\$1436.00); Off site Craft Shows (\$2304.00); and E-Commerce (internet/wholesale sales of merchandise) (\$17816.00).

Comment 11: Part XI, Line 9--Other changes in net assets or fund balances. The method used by Son Glow Ministries, Inc to pay the rent of the building housing Son Glow Boutique, the ministry's retail store, is a bill pay service through a local bank. When the delivery date occurs on a weekend or day, the bank adjusts the delivery date to the day before of day after the required date. In this instance, the bank paid the next month's rent the last business day in December and was treated as a prepaid expense.

Comment 12: Part XII, Line 3b--"No" response. Son Glow Ministries, Inc did not receive a federal or state grant or award, therefore, no audit or audits were required. Had such an audit been required, Son Glow Ministries, Inc would have contacted a professional accounting firm to perform the audit. The Son Glow Ministries, Inc's audit committee would review the findings in the audit report and implement action to remedy/correct negative practices.
