During 2015 St. Francis House provided, free of charge, \$10,439 of sleeping bags and \$12,750 of backpacks to the homeless. Additionally, St. Francis House provided \$12,144 of clothing and diapers, \$3,676 of toothbrushes, toothpaste, and razors. St. Francis House also provided \$5,422 in rent and utility assistance and \$6300 in transportation assistance.

In 2015, St. Francis House served approximately 60 people daily. In addition, St. Francis House served hot beverages and sandwiches to another 40 people daily.
