Conservation of the endangered Snow Leopard and its mountain ecosystem In 2015 the Snow Leopard Trust worked with more than 16,000 people in 4000 households in 50 communities to implement programs that not only protect wild snow leopards but also improve the quality of life of the participating communities Our programs were livestock insurance, livestock vaccination, corral-building, and a handicraft program called Snow Leopard Enterprises As part of these programs herders signed Conservation Contracts in which they agreed to protect snow leopards and their key prey The Snow Leopard Trust also continued its role as the lead technical advisor to the Global Snow and Ecosystem Protection Program (GSLEP) developed out of the 2013 Global Snow Leopard Forum In 2015, as part of the GSLEP, the United Nations Climate Change Conference met on impacts of climate change on Snow Leopards The goal is to increase protection across 23 landscapes to support more than 2000 snow leopards by 2020 "

Education, awareness and capacity building for snow leopard conservation We provided environmental educational, skills-training, and outreach to adults and children Over 1,100 children in snow leopard habitat took part in Nature Clubs--school-based environmental education curriculums implemented in over 60 schools in snow leopard habitat We took 300 children on eco-camps in the mountains in Mongolia and India Eco-camps are experiential and hands-on learning consisting of an introduction to the snow leopard, biodiversity and food web, biological adaptations of generalist and specialist species, climate change, understanding greenhouse effect, human interaction with wildlife In addition to children, we provided targeted skills-training to rangers in snow leopard habitat We trained 23 ranger in Kyrgyzstan on improved law wildlife law enforcement, and provided awards and social awareness on a national level for their efforts in apprehending illegal poachers We used mass media to raise awareness for snow leopard protection on a national level in Mongolia

Research and monitoring of Snow Leopards and their environment In 2015, we continued our long-term snow leopard study in South Gobi, Mongolia to increase our understanding of snow leopard ecology, behavior, and habitat needs This study includes GPS collaring/tracking, trap camera surveys, prey surveys, data collection related to snow leopard disease and disease transmission, and assessment of livestock grazing impacts on the health and abundance of wild prey In addition, we are working to expand similar research in China, India, Kyrgyzstan, and Pakistan We launched a multi-country study of impacts of climate change on rangelands in snow leopard habitat, and prepared for snow leopard collaring in India
