These funds are for the benefit of College programs, their students, and our in house high school academy program. In 2015, we spent about \$101,500 for gas cards, lunches, and class support for Academy students. The Foundation spent \$9,300 to support LWIT student inter-college competitions and conferences, and \$5,900 for Faculty program conferences.
