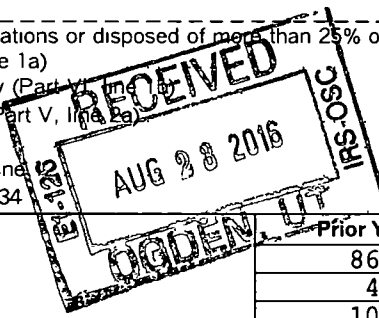

Grants for Artist Projects (GAP) provide support for artist-generated projects which include (but are not limited to) the development, completion or presentation of new work. Recipients are selected through an open, competitive panel process. There were 61 GAP recipients from 7/1/15- 12/31/15.

The James W. Ray Distinguished Artist Award Award is an unrestricted award of \$50,000 given annually to a WA State artist working in any discipline whose work demonstrates exceptional originality. Ray Venture Project Awards are two unrestricted awards of \$15,000 each given annually to support artistic excellence and the development of new ideas through individual and collaborative projects by artists of all disciplines living and working in Washington State whose work demonstrates exceptional originality.
