SUPPORTING SMALL BUSINESS Main Street Alliance (MSA), AJS's network of state-based small business coalitions, worked to build the voice of small business owners through outreach, education & leadership development focused on issues that impact small business owners, their employees & local economies. Issues included earned sick time, economy-boosting wages, & paid family & parental leave, tax fairness, money in politics, immigration reform, affordable health care, & retirement security. MSA conducted a survey of 1,163 small business owners & published a report called "Voices of Main Street." MSA worked to cultivate small business owner leadership in the media, in public forums & business to business engagement. MSA organized a #HateHasNoBizHere campaign to counter the alarming increase in anti-Muslim, anti-immigrant, anti-people of color rhetoric & violence in late 2015. The campaign reached over 3.4 million people. Significant advances include bringing positive small business voices to the conversation in support of earned sick leave in OR, NJ, VT, MN & WA & fair hiring in FL.

RESEARCH, POLICY & COMMUNICATIONS AJS conducted research to support work on economic issues facing families in 16 states & the District of Columbia. AJS produced 4 reports in our annual Job Gap Economic Prosperity series. These reports calculate what it takes for families to make ends meet, which families are or aren't earning a living wage, & strategies & investments that could be used to create living wage jobs. AJS wrote & released a national report, Breaking Barriers, that drew on over 1,000 field surveys & in-depth interviews with community members & experts to identify barriers to enrollment in health coverage & access to health care for low-income people, people of color & rural communities. AJS also produced state-specific reports in 9 states which helped advance public dialogue around health coverage. AJS conducted additional research & communications activities focusing on Medicaid expansion, health equity & the potential impact on consumers of proposed insurance company mergers & increasing consolidation in the private health insurance industry.

PUBLIC EDUCATION & COMMUNITY ENGAGEMENT AJS supported community organizations in their work to educate the public about access to living wage jobs, the benefits of Medicaid expansion, ending racial health disparities, ending hunger, skyrocketing student debt, legal financial obligations & discriminatory local fines/fees that harm communities of color. This education led to community engagement with over 80 actions & events on a range of issues: a national event connecting over 200 people to share their experiences with debt & explore solutions to the national debt crisis, over 20 actions on the importance of raising the minimum wage & creating jobs that pay a living wage, over 30 actions on expanding access to quality, affordable health care, activities on immigrant rights educating community members about opportunities to adjust their status & taking action in support of Syrian refugees, hearings on the student debt crisis in 3 states, activities around legal financial obligations, fair hiring practices & racial profiling in 5 states, & activities related to money in politics.
