Buddy Walk program is used under license from NDSS, and the program is focused on community awareness and advocacy.

An opportunity for families and individuals to collect as a group and participate in a walk and outdoor recreation.

Speakers address many topics related to disabilities, and other programs of NWDSA are shared with families.

This is an outside venue event and various members of the community come together to support individuals with disabilities.

A secondary focus is the ability to sponsor teams on the website, but the event is not primarily a fund raising event.

(Expenses exclude indirect general overhead costs. Grants include sponsorships - which keeps event affordable for families).

All Born In is a cross disability all day training for professionals, parents, and self advocates. About 50% in attendance receive continuing education credits. The training is very comprehensive and includes over 40 individual break-out sessions.

A comprehensive survey of attendees is completed to measure the effectiveness of the training.

Translation services are available for hispanic families, as well as signing for those with hearing impairments.

The event generally has 450 in attendance and trainers from all over the US and Canada.

Bike First is an event that provides special training with state of the art technology that helps reach young people with disabilities how to ride a bike in a safe and effective manner. It is held at a local university and has both paid and volunteer staff. The program is well received and is supported by many donations. It fits well with the overall goal of helping individuals with a disability become physically capable and builds confidence. Many young people will learn to ride a bike for the first time at this event.
