Grantmaker's Description of How Grants are Used	Each year ASGCT gives excellence in research awards to ASGCT Associate Members who received the highest abstract scores of those submitted to the ASGCT Annual Meeting. The scores are given through a peer review process by the Abstract Review Committees. The awardees receive a \$500 cash award and travel reimbursement award (up to \$500) to attend the Annual Meeting. The Outstanding new Investigator Awards are given to up to four ASGCT active members who have been nominated by two ASGCT active members. The nominees must be seven years or fewer from their first Assistant professorship and be conducting independent research. The nominations are submitted to the ASGCT Advisory Council for consideration. The Advisory Council then submits the recommendation to the ASGCT Board of Directors for approval. The Awardees are given a \$1,000 cash award and present their work during the Outstanding New Investigators Symposium at the ASGCT Annual Meeting. The Editor-in-Chief of the Molecular Therapy journal receives a \$10,000 stipend and each Deputy Editor receives a \$2,500 stipend from ASGCT in the last quarter of each year of the position. The stipend amount is reviewed by the Board during the budgeting process and written into agreement with each new term of the Editor-in-Chief.

Emeritus Member status shall be granted, if approved by the Board of Directors in its sole discretion, by majority vote. Emeritus Members shall have all privileges of Active Members except that they shall not have the right to vote, hold office, serve on committees, or serve on the Board of Directors.

The Executive Director discusses the conflict with the Executive Committee to determine the appropriate remedial action based on the disclosed conflict. Speakers presenting at a Society meeting are required to fill out a disclosure document and a faculty compliance document prior to speaking. The documents are reviewed by the Society. Any speakers who have a conflict are also required to submit their presentation slides for review and include a disclosure slide prior to their presentation so that the audience is aware of the relationships they have to disclose. The Society produces and distributes to each program attendee a printed disclosure document that compiles any disclosures of every faculty member. The Society also distributes two surveys at each program: one to the chair of the session and one to each audience member which asks them to indicate if the presentations by any of the faculty contained bias.
