Additionally, the auditors recommended reclassifying some of the fixed assets, including the determination that an asset previously considered intangible is actually a tangible asset. The overall result of the amendments is an increase in revenues of \$665,941, a decrease in expenses of \$43,744, and an increase in net assets of \$191,206. There is no tax effect of these changes, as they simply increased the NOL carryforward by \$38. As a result of the audit, and the fact that the financial statements are produced using the accrual method of accounting, it was determined that B'Nai Brith will make the change to the accrual method for tax return filing purposes, as well. This change in accounting method is reflected on this amended return, please also see the attached form 3115.
