The Bainbridge Island Parks Foundation enhances community by supporting a thriving system of parks, trails and open space on Bainbridge Island. This is done primarily through working with the community to fund parks improvement projects on Bainbridge Island, and supporting the expansion of trail networks on Bainbridge Island by helping the Park District to obtain trail easements, and by funding a program to construct and maintain trails.

Parks project. Grants to the Bainbridge Island Metropolitan Park and Recreation District (BIMPRD) for park enhancement projects. These grants support parks facilities and recreational opportunities through grants for park stewardship, special projects and pass-through grants for projects. Includes a special project grant to the BIMPRD for new gymnastics "spring-floor" for gymnastics program, which provided facilities to 7,000 participants in 2015 gymnastics programs. Pass-through grants from the Bainbridge Community Foundation include support for a new accessible playground and a storage unit for outdoor programming equipment. A grant supported the Student Conservation Corp--a work/learn experience for 24 youth that provides invasive weed management in parks and also conservation career education for participants.

(Code) (Expenses \$ 40,526 including grants of \$ 26,600) (Revenue \$)

Trail Projects. Grants to support trail system managed by the Bainbridge Island Metropolitan Park & Rec District. Hundreds of individuals use these trails daily, for over 40,000 trail users annually. A grant supported the purchase of three trail easements, providing a permanent trail connection between two parks. Another grant supported a 6 week summer Trails Crew that constructed approximately 1.5 miles of new trails and provided maintenance to an additional 2 miles. The Parks Foundation initiated a trail acquisition program improvements in 2015 by engaging a Trail consultant to advocate on project practices and methodologies.

Community Grants program. 4 grants were awarded to fund capital projects that improve recreational opportunities on Bainbridge Island. These grants supported 4 projects: a new pottery kiln, a new gymnastics apparatus, a new racing sailboat and support for a new community center. Hundreds of community members will benefit with many years of use from these new facilities and equipment.
