The donors set the prices, based on actual retail price, competitive analysis, or the amount that was charged at auction for the item.

Line 1 - Art. Retail value was determined by donor. Some articles sold for considerably less than the stated value.

Line 5 - Clothing, art, jewelry and gift baskets. All items were in new or new-like condition. Retail values were determined by the donors.

Line 6 - Collectibles. Signed Seahawks jersey and other Seahawks gear; sold at auction for more than this amount.

Line 19 - Food. Desserts were valued at \$15, gourmet dinners at \$25 - \$62.50 per person, restaurant gift certificates at retail value.

Line 25 - Experiences were museum tickets, sports lessons, weekend getaway adventures. Amounts were based on actual retail, comparable value, or the amount actually charged at auction.

Line 26 - Lodging was the donation of condo stays; amounts were based on comparable value, as from VRBO or AirBNB.

Line 27 - Services. These were things like housecleaning or SAT prep classes; amounts were the actual retail cost.
