Since 1955, Providence Benedictine Nursing Center (PBNC) has been a model of excellence, innovation and best practices that include spiritual and emotional support in addition to physical care. Contributions towards operating funds help PBNC better serve the frail elderly. In 2015 donations were used for a variety projects. A new non-skid kitchen floor was installed for \$90,000. The foundation provided \$52,000 for charity care for patients and residents who could not afford the full cost of their care. Our new hospice received \$105,000 to help offset start up costs. Donated funds were used for equipment needs of nineteen residents who had no ability to pay for them. The funds paid for a specialty wheelchairs as well as other equipment. The special wheelchair was for a resident who lacked the core strength to sit upright. The custom chair was designed to support her properly so that she could get out of bed and participate in activities and meals in the common area. Her family could push her around the nursing center and to the garden and new art walk. A long barren hallway was transformed into an art walk. Art from the intergenerational program (children from Child Development Center and residents working together on art project) is displayed in reusable frames paid for by the foundation. Community art exhibitions are hung from a track and cable system purchased at the same time. Funds will also pay for additional training for staff so that they can learn more techniques to teach residents to use art to express themselves. Scholarship funds provided by donors were used to help families afford tuition at our Child Development Center. The CDC offers high quality care to employees and families from the community who then benefit from the interchanges that occur when they interact with patients and residents in the nursing center and Orchard House Assisted Living. Foundation funds paid for the cost of having a priest visit and say Mass six days per week. This enhances our already robust spiritual care services even more. Donations pay for many of the programs, projects and equipment that make PBNC an excellent place for care.

Providence also maintains a network of community ministry boards with responsibility for quality of care oversight, community relations, advocacy and community needs assessments. The Board retains an independent consultant each year to review salaries of those in the most significant leadership roles in the organization. Part of the consultant's role is to review an extensive array of compensation surveys of large, not-for-profit health care systems in the United States. Providence is one of the larger health systems in the country, and as such, the Board benchmarks executive compensation against other large, not-for-profit health systems whose revenue is similar to that of Providence. Base salaries for Providence executives are set at the median level of the market, as identified by the independent consultant and reviewed with the Human Resources Committee. Performance incentives allow executives to earn additional compensation if they achieve specific organizational and individual goals for furthering Providence operating principles - advancing the Providence Mission and core values, meeting benchmarks for charity care, achieving quality targets, delivering top-rated customer satisfaction, meeting employee satisfaction goals and reaching financial performance objectives. The Board of Directors conducts a thorough process to ensure performance incentives are aligned with appropriate practices for not-for-profit health care systems. The Board's process for executive compensation fully complies with IRS standards and mirrors the best practices recommended in the "Report to Congress and the Nonprofit Sector on Governance, Transparency, and Accountability" submitted to the Senate Finance Committee by the Panel on the Nonprofit Sector. The Foundation Executive Director is compensated by a related organization which uses a market based compensation program utilizing several independent third party compensation market surveys to establish pay ranges for the position. The related organization then establishes the individual rate of pay within the range based on relevant experience, skills and competencies. The rate offered to the Executive Director at the time of hire was determined through discussion between the Regional CEO, Regional Director of HR and the Administrative Director of HR. The ranges and rate of pay are reviewed on an annual basis by Regional HR.</p>
