Provide access to orthopaedic training and education to surgeons in developing countries - This is accomplished through onsite visits by North American and European surgeons, local surgeons, email communications with SIGN Headquarters, the review of cases submitted onto the SIGN Surgical Database by orthopaedic surgeons on the SIGN Board, regional SIGN and trauma conferences, and the annual international orthopaedic conference held at SIGN Headquarters The objectives for all modes of training are 1) ensure SIGN Surgeons understand the surgical technique for the SIGN products in their hospital, 2) provide training on current and relevant orthopaedic principles, and, 3) provide training in orthopaedic and trauma procedures for injuries such as open wounds, limb deformity, pediatric, and pelvic To further our educational materials, the SIGN Surgeons website now has a Fracture Forum where Dr Zirkle posts technique related comments based on his observations from the previous week’s database case entries Establish Regional Trauma Courses as another means of distributing appropriate orthopaedic technology - The SIGN Orthopedic Conference held at SIGN Headquarters has been a tremendous experience for the SIGN Surgeons However, the conference is limited to 150 participants SIGN has a long term goal to establish regional trauma courses In 2015, we partnered with other organizations to conduct the third regional trauma course in Port au Prince, Haiti and one in Dar es Salaam, Tanzania The Haiti course was organized in conjunction with Project Hope, Partners in Health, and SIGN Faculty came from surgeons that volunteer with SIGN and with Partners in Health Faculty also included the local Haitian surgeons The event was well received and nearly every Haitian orthopaedic surgeon attended Plans were made to continue the conference in 2016 A similar format was implemented at Muhimbili Orthopedic Institute (MOI) in Dar es Salaam SIGN partnered with MOI and the Institute for Global Orthopedics and Global Traumatology (IGOT) to develop the curriculum and attract faculty The course was promoted to hospitals throughout Tanzania and East Africa It was attended by 100 surgeons from several East African countries This conference was also well received and plans were made to hold it again in 2016 The surgeons who attend our conferences are highly appreciative Below is a sampling of the comments we received in 2015 from the conference evaluation forms Question How will the presentations today change your technique of using SIGN Nail?- Adherence of fracture reduction and reaming through whilst the fracture is reduced I considered decision making for complex fractures that might need change of the standard insertion protocol e g , medial incision of the entry point, change of the angle of insertion of the nail to improve the stability of the fracture fixation - I learned to be much more careful with subtrochanteric femur fractures consider more medial entry, put standard sign nail in with bow medial and holes ant-post, make sure reduction is good and maintained during reaming and nail placement I now take into consideration a lateral plate to temporarily hold reduction and add to standard nail construct Question What changes in your practice will you make based on the presentations today?- Recognition of ischiopubic segment rotation in transverse family of acetabulum fractures and the way to correct it - Dr Kyle made me realize that trying is not enough but perfection is the target I learned better preoperative templating using the pelvis model, not just a drawing I won't let my implant go above the groove Other comments - I am very thankful and truly appreciative of this experience I didn't only gain knowledge and skills but more importantly I gained affirmation of the right attitude towards patient care through SIGN SIGN is not only about nail It's a family of surgeons and non-surgeons working together with a common goal of serving the patients with an adequate knowledge, competent skills and a compassionate heart

Distribute appropriate orthopaedic technology - The SIGN IM Nail and Interlocking System is designed for use in hospitals in developing countries where C-arms and regular power are not available SIGN engineers continually develop new orthopaedic instruments and implants in response to the needs described by the local surgeons In 2015, the following two systems were cleared by the FDA 1) SIGN Hip Construct, consisting of Hip Nail, HV plates, and Series V screws, and, 2) Compression screws for use in Femoral Neck Fractures New programs are supplied only with the SIGN IM Nail System, which is used to repair severe fractures in the femur, tibia, and humerus Once the program has demonstrated its ability to report their cases, including adequate follow-up which confirms their results comply with our expectations, they become eligible to receive additional SIGN products, as well as in-kind donations received from for-profit orthopaedic implant companies We distributed 24,200 implants to more than 50 countries Our aim is to enable the poor to gain access to affordable orthopaedic surgery which means that the majority of our implants are donated free of charge to the patient 20 new programs were started in 2015 Africa took the lead with 10 new programs, followed by Asia with 6, North America (Haiti and Dominican Republic) with 3, and South America with 1 As of December 31, 2015, the World Bank income classifications by GNI for SIGN Programs were as follows Low Income 47%, Lower Middle Income 41%, Upper Middle Income 12%, and Upper Income 0% Distribution of SIGN Implants can take the form of disaster response - SIGN volunteers from North America and Europe respond to disasters in countries where SIGN Programs currently exist or where SIGN Programs would be beneficial Most often, as in the case of the 2015 earthquake in Nepal, it is the local SIGN Surgeons who provide the disaster response using the SIGN equipment already in the country In these cases, our response is to send replenishments of SIGN equipment along with other donated materials they request SIGN Surgeons in Nepal were well equipped to immediately care for the patients with fractures resulting from the earthquake They did not request personnel, but rather replenishment of implants and other medical supplies We were able to arrange immediate shipments of SIGN equipment as well as other donated materials all of which safely arrived in Nepal and were promptly distributed
