**Explanation:** For the past many years, Run Seal Beach ("RSB") has timely filed its Form 990 prior to the May 15th deadline. RSB is an all-volunteer organization and strives to comply with all current rules and regulations. In late November 2015, RSB experienced the sudden resignation of its President and Treasurer (two of its three Directors at that time) which led to a delay in the completion of the 2015 books and miscommunication regarding the 2015 tax filing. The newly appointed Treasurer was able to complete the accounting for 2015 in late August 2016 and forwarded the information to the CPA/tax-preparer, but then resigned her position as well. The CPA/tax-preparer began the tax return preparation as time permitted after the October 17th extended individual tax deadline had passed. During the preparation it was determined that no extensions had been filed for the RSB Form 990 due to miscommunication between the new RSB officers transitioning into their new positions and the CPA/tax-preparer. Had the proper extensions been filed as intended, the RSB 2015 Form 990 would be considered a timely filed tax return. RSB has subsequently appointed a new Treasurer to replace the Treasurer who remained in the position for approximately 9 months. The new group of Officers and Directors is functioning well and now has policies in place to ensure full compliance will all upcoming tax filing deadlines. Based on this information and Reg. 301.6652-2(f), I respectfully request that any late filing penalty due under IRC Secs. 6652(c)(1)(A) and 6652(c)(4) be waived for reasonable cause.
