In 2015, the Organization conducted the Strength from the Roots, an art and cultural enterprise in the Inland Valleys, for under-paid workers, immigrants, and African American long term residents The organization concentrated on promoting immigrant rights and accompanying immigrant families to visit detained relatives, providing economic literacy and justice training to faith and community leaders in the Greater San Francisco Bay Area, and, expanding a health and wellness program to reduce health disparities among highly at-risk populations, including African American, Latino/a and Samoan communities in Los Angeles Clergy and Laity United for Economic Justice, California (CLUE CA) changed its name to Interfaith Movement for Human Integrity (IM4HumanIntegnty) and focused on developing a Strategic Plan to carry out its mission The Organization held public events among interfaith leaders and groups to heighten public awareness about statewide social, racial, and economic justice issues
