The timing of these grants is important as often times they must be coordinated with the availability of staff to participate in the work and other funds that are available through state parks.

In 2013 the RSPF took over the operation of a convenience store at the major campground, a function that the park staff could no longer accomplish. While the park has a volunteer coordinator (which the RSPF helped fund through a grant), many of the volunteer projects are supported by members of RSPF, such as trail work on the multi-use trails and participation at community events representing the park. Events are held in the park, such as the Zombie Hike and Winter Wonderland that have been taken over by the RSPF for operation. These events bring people into the park increasing the use and providing financial support through the sale of Discover Passes.
