2015 was a busy year for Live Work Play In January, the latest metrics were released in conjunction with the new Live Work Play magazine The 2015 Live Work Play magazine was published by Alaska Dispatch News and distributed with their Sunday newspaper The momentum that this initiative is gaining was all the more evident this summer when newly elected Mayor Ethan Berkowitz chose LWP as one of his transition sub-committees and continued to work closely with AEDC to incorporate LWP into his administrations priorities AEDC's #iloveanchorage instagram account gained 8,400 followers and the Live Work Play survey collected responses from nearly 1,300 community members

In 2015, AEDC continued efforts to help both local businesses and businesses from outside Alaska in an effort to support increased investment and expanded employment Efforts resulted in AEDC providing assistance to 163 companies 112 of those companies were based within Alaska and 51 companies were based outside AEDC also hosted the International Economic Development Council's annual conference where 1,300 site selectors, economic development professionals and consultants convened in Anchorage for a week of seminars, training and tours The econmic impact on the city is estimated to be several million dollars
