NY CityFest Radio City Music Hall July 7, 2015 Luis & Andrew Palau On July 7, Luis Palau and Andrew Palau, along with artists Third Day, Amanecer, David Ganbaldi, and Newsboys joined the ranks of legendary performers who have graced the stage of Radio City Music Hall in Manhattan Hundreds of people from New York City and surrounding areas packed the venue, and thousands more tuned in via live webcast and a live broadcast through ministry partner Enlace Amanecer opened the show with acapella vocal performances in both English and Spanish, and were followed by New York Times Bestselling Author Eric Metaxas, who shared his personal story of transformation through faith in Jesus Third Day, Newsboys, and David Ganbaldi--a graffiti artist who shared his unique gift of live painting as a contestant on the 12th season of "American's Got Talent"---followed with performances of their own Andrew Palau then took the stage to introduce his father Luis, speaking of him as both his spiritual father and his earthly father Luis then wove together stories and testimonies of radically changed lives along with the Good News of Jesus Christ He shared with the crowd "God knows you by name, He wants to meet you and be with you and He will never abandon you!" NY CityFest Times Square July 10, 2015 Luis & Andrew Palau At Times Square--one of the most well-known and beloved landmarks in the United States--Luis and Andrew Palau joined with TobyMac, Matt Redman, Mandisa, and Amanecer in a truly historic moment for the Gospel in New York City As thousands of people passed through at one of the busiest times of the day, Luis and Andrew shared the Gospel and extended the invitation to accept the Lord multiple times and each artist performed to a crowd packed so tightly that the only way to get around was a narrow walkway on either side of the square From the stage, Luis shared about the beauty of salvation and his personal desire to see the entire city come to faith "We want all of New York City to know that God loves them, and will save them from their sins! I'll give you an opportunity, right here in Times Square, to give your heart to God!" Throughout the three hours of stage time, Luis and Andrew invited people to give their lives to Christ several times Each time, they invited those in the audience to raise their hands if they had made a decision for Christ Hands shot into the air throughout the evening at each invitation--some from the center of the crowd, but some from the outskirts, perhaps passersby who had just happened to stop and see what was going on One of the festival goers happened upon the event because he had made plans with a friend to meet up in Times Square He shared his impressions of the event "I rounded the corner and thought, wow, that's a lot of people! I felt like I was in church yea, it was like there was church in Times Square!" NY CityFest Central Park July 11, 2015 Luis and Andrew Palau Thousands of people representing multiple languages, ethnicities, and cultural backgrounds gathered in a beautiful display of unity to lift high the name of Jesus at New York City's Central Park on July 11 It was a fitting capstone to a historic campaign that reached 180,000 people in person through more than 115 events in one of the most influential cities in the world It was one of the only large-scale evangelistic gatherings of its kind to ever take place in Central Park "This is such a beautiful scene of people coming together under a common cause," New York City Mayor Bill de Blasio shared as he greeted the crowd from the stage "CityFest is now part of our history You are showing how much communities of faith contribute to civic life "De Blasio was joined by Andrew Palau, Manano Rivera, Mandisa, TobyMac, Amanecer, Matt Redman, Rescate, Marcos Witt, Hezekiah Walker, and surprise artist Chns Tomlin to join Luis in proclaiming the Gospel to the thousands in attendance Between musical performances, speakers, and more, the day was devoted to sharing the Good News with those in attendance and celebrating all that was accomplished throughout the week "I hope you'll do what I did when I was 17 years old, and surrender your heart to Jesus," Luis shared from the stage "If you feel lost tonight, you've come to the right place This is your moment with God, right here in Central Park " NY CityFest Regional Outreaches May July, 2015 Luis and Andrew Palau, partner evangelists Throughout the months leading up to the three main events in Manhattan, Luis and Andrew Palau shared the Good News at multiple smaller events throughout New York City There was at least one event in each of the five boroughs--Brooklyn, the Bronx, Manhattan, Queens, and Staten Island--along with Long Island, New Jersey, and Connecticut Andrew Palau also shared the Good News at Ryker's Island Correctional Facility Through strategic partnerships with evangelistic organizations, non-profits, and churches throughout New York City, there were 115 NY CityFest events and outreaches Artists such as Gungor, David Crowder, Mansol, TobyMac, Matt Redman, Tedashii, and more were featured artists at events In total, there were more than 10,000 recorded decisions for Christ through NY CityFest events

Fun in the Son Haiti November 2015 Andrew Palau Just two weeks after the results of the Presidential election sparked an extended period of widespread political unrest, thousands of people gathered in the heart of Haiti's capital city for a free, city-wide outreach festival featuring evangelist Andrew Palau. The event, known as Le Chic Poulet Fun in the Son Festival with Andrew Palau, was a collaborative effort between the Luis Palau Association, Haiti Broilers, and hundreds of Christian churches. The goal was to foster hope in the Caribbean nation and to share the Good News of Jesus Christ. Many evangelistic events and service projects took place throughout the city in the days leading up to the major gathering. From November 7 until November 14, gatherings were held for business and civic leaders, women, children, prisoners, and more. The week concluded with the gathering of thousands in the heart of Port-au-Prince and featured popular local musical artists, professional BMX athletes Vic Murphy and Jon Andrus, freestyle motocross champions Justin Homan and Derek Garland, a special program on the main stage just for children and families, and a message of hope from Andrew Palau. The crowd was joyful and exuberant as they marveled at the high flying stunts from FMX and BMX athletes and danced along to the upbeat musical performances. As Andrew shared about the loving intent of Jesus Christ for their life, to provide abundance in life, as described in the Bible in John 10:10, hands were raised across the crowd representing those who had made a decision to respond to the call to believe in and follow Jesus. By the end of the week, more than 2,300 individuals had registered a decision to follow Christ. Each decision maker received a Bible and discipleship materials and are in the process of being followed up by one of the 600 participating local churches.
