Payments to, or on behalf of, Providence Hood River Memorial Hospital * The Providence Hood River Area of Greatest Need fund supports many programs with one of the largest in 2015 being the Julie Beliel Cancer Screening Program that provides free mammograms to uninsured and underinsured individuals The program also provides prevention education to those with barriers to access The fund also supports the work of a community health worker doing breast health education via a popular education model through a partnership with Susan G Komen Foundation * Hospice Area of Greatest Need fund helps hospice patients get what they need to have the best quality of life during this difficult time Medical supplies are purchased in unique situations where insurance doesn't cover the need (or when there is no insurance) Music therapy, massage therapy, acupuncture and other complimentary therapies and services are also covered here When these items are not covered by insurance we provide them to hospice patients through this fund * The Don Benton Cancer Services fund provides additional services for patients undergoing chemotherapy such as appearance services, massage during chemotherapy, support groups and healing art classes * The Providence Hood River Memorial Hospital Foundation participates in the Gorge Dental Access Coalition that provides \$500 vouchers for children without dental insurance Gorge area dental providers use the vouchers to provide cleanings and minor procedures, but most importantly they start the child's education about oral health Since 2007, over 245 children have been served by the program

Providence has a single fiduciary Board, with responsibility for financial oversight associated with fulfillment of the Providence Mission, developing system policies, protecting the assets entrusted to the organization and overseeing the strategic and operational affairs of Providence's legal entities. Providence also maintains a network of community ministry boards with responsibility for quality of care oversight, community relations, advocacy and community needs assessments. The Board retains an independent consultant each year to review salaries of those in the most significant leadership roles in the organization. Part of the consultant's role is to review an extensive array of compensation surveys of large, not-for-profit health care systems in the United States. Providence is one of the larger health systems in the country, and as such, the Board benchmarks executive compensation against other large, not-for-profit health systems whose revenue is similar to that of Providence. Base salaries for Providence executives are set at the median level of the market, as identified by the independent consultant and reviewed with the Human Resources Committee. Performance incentives allow executives to earn additional compensation if they achieve specific organizational and individual goals for furthering Providence operating principles - advancing the Providence Mission and core values, meeting benchmarks for charity care, achieving quality targets, delivering top-rated customer satisfaction, meeting employee satisfaction goals and reaching financial performance objectives. The Board of Directors conducts a thorough process to ensure performance incentives are aligned with appropriate practices for not-for-profit health care systems. The Board's process for executive compensation fully complies with IRS standards and mirrors the best practices recommended in the "Report to Congress and the Nonprofit Sector on Governance, Transparency, and Accountability" submitted to the Senate Finance Committee by the Panel on the Nonprofit Sector. The Foundation Executive Director is compensated by a related organization which uses a market based compensation program utilizing several independent third party compensation market surveys to establish pay ranges for the position. The related organization then establishes the individual rate of pay within the range based on relevant experience, skills and competencies. The rate offered to the Executive Director at the time of hire was determined through discussion between the Regional CEO, Regional Director of HR and the Administrative Director of HR. The ranges and rate of pay are reviewed on an annual basis by Regional HR.</p>
