We develop tools, resources and analysis and provide training and organizational support to help groups and their constituencies advance policies and change hearts and minds. Our Gender Justice Program is We are BRAVE (Building Reproductive Autonomy and Voices for Equity) entered its second year in 2015 with incredible growth, doubling in size and bringing in new individual leaders to continue the work for reproductive justice. Reproductive justice will be realized when all people have the economic, social and political power, and the resources, to make healthy decisions about their own bodies, genders, sexualities, and families -- for both themselves and their own communities. We are BRAVE works with organizations and individuals to break the shame, stigma and silence around reproductive health care access, from conception to birth

Leadership Development is woven throughout all of our programs at the Center. Our stand-alone leadership development conference AMP (Activists Mobilizing for Power) returned in 2015. The conference is designed for social change organizers and activists from across the country to sharpen skills, expand analysis, and connect with other organizers working for justice, it will return in 2017.

4c (Code _____) (Expenses \$ 79,562 including grants of \$ _____) (Revenue \$ 85,843)

The Racial Justice Program supports organizations building power in communities of color, immigrant and refugee groups and communities in addressing vital racial justice issues. In 2015, we produced the third edition of Facing Race. The Oregon Legislative Racial Equity Report, which we coordinated with six community-based organizations and was endorsed by 33 community organizations. The community education tool, used with legislators and the general public to highlight racial equity policy and the status of legislation impacting communities of color in Oregon, may be reviewed online at facingraceoregon.org. The Center worked with a wide range of groups in 2015 to hone their strategies for racial justice and share our own best practices through training, presentations and coaching. Our work facilitates theory into action for racial justice.
