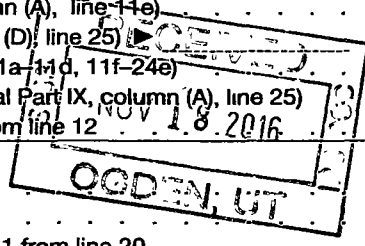

CAMP MORNING STAR: Youth from 8-18 were provided low cost camping. Youth were motivated to set career goals, continue their education, and say "NO" to drugs and gangs. Churches and service organizations are provided with time to enjoy nature and reflect on character building themes.
In 2015, almost all of the 50 toilets in camp were changed out to water saver toilets. Also, 10 buildings had ceilings lowered and insulated so they are usable in winter months. Wall furnaces were also installed in 16 buildings. This accounts for the marked increase in expenses during 2015.
